



To achieve this objective and its digitalisation ambitions, the law firm needed to refresh its ageing and complex infrastructure with an environment that would deliver greater agility and resilience.

## SOLUTION

Eversheds Sutherland worked with Computacenter's experts to design and deploy a private cloud that supports 4,000 users around the globe. The environment is hosted off-premise in a Computacenter datacenter and monitored 24x7 by its capacity and service management teams to ensure maximum availability and scalability.

## OBJECTIVE

### Access to the right information at the right time for clients and lawyers

To deliver consistent services, Eversheds Sutherland needs to ensure its people and clients have access to the right information at the right time. "People associate law firms with folders and filing cabinets," says Andrew McManus, IT Director at Eversheds Sutherland. "As part of our digital transformation, we are pioneering a completely new approach that will enable us to share and store information easily and securely."

To achieve its digitalisation and data ambitions, Eversheds Sutherland needs scalable and flexible systems both in the datacenter racks and on users' desks. "Our lawyers work in a very agile, even iterative way with our clients," explains McManus. "We need to ensure our systems can respond to that demand, which means the IT team needs to work at speed and at scale."

### Maximising capacity, minimising complexity

For Eversheds Sutherland, moving to private and public cloud services is a key part of achieving this agility. "By embracing a hybrid cloud approach, we can ensure that our IT infrastructure is primed to grow with the business and evolve with our clients needs," explains McManus. "We can also uphold robust security controls without having to buy, build or maintain systems in-house."

Replacing its complex and ageing datacenter set-up was an important first step. "Our existing infrastructure needed to be refreshed to provide greater resilience and scalability," says McManus. "We recognised that moving to a private cloud would provide us with a one-stop-shop that we could trust."

## SOLUTION

### Boosting agility and reliability with scalable private cloud

Eversheds Sutherland has been working with IT partner Computacenter for more than 10 years. "When clients demand something new, we tend to turn to Computacenter first," adds McManus. "It has a lot of experts and commits to specific outcomes."

McManus and his team worked closely with Computacenter's technical architects and commercial team to design a private cloud that met its expectations for agility, service quality and scalability without exceeding its budget. Hosted in Computacenter's Tier IV datacenter in Romford, the environment provides 4,000 users around the globe with secure and reliable access to a range of critical financial, legal and operational workloads.

The environment is managed 24x7 by Computacenter's Infrastructure Operations team, as Julian Wase, Group Managed Services Director explains: "Our dedicated capacity and service management teams ensure that the private cloud meets Eversheds Sutherland's availability, interoperability and scalability needs as they evolve. We match the private cloud's architecture to future business goals to ensure there's always room for the next workload or digital service."

As part of the private cloud implementation, Computacenter also helped Eversheds Sutherland establish a devtest portal to enable the dynamic provisioning and management of environments to support new client and digital initiatives.

The private cloud, which is founded on a Vxblock system, Cisco switches, Veeam and Data Domain backup solutions, and Citrix load balancers, will eventually replace around 600 legacy servers. "With Computacenter provisioning and managing our infrastructure, we don't have to worry about any complex arrangements to keep the lights on – it's all done for us," says McManus. "As a result, we can focus more time on innovation and improvement and delighting our clients."

## OUTCOME

### Empowering lawyers to work more effectively

Lawyers and their business services teams at Eversheds Sutherland can now access vital information more easily, regardless of where they are. This aligns with the firm's goal of saving every lawyer an hour a day, freeing them up to spend more time with clients. "The private cloud will provide us with the foundations we need to digitalise and centralise our client-facing data," says McManus. "Providing our lawyers with access to technologies that make their lives easier helps us to attract and retain the best legal talent."
